### Overview

**Aviation is now included in the European Union Emissions Trading Scheme (EU ETS).**

CO<sub>2</sub> emissions of all FAR Part 91 flights to, from and within the EU must be reported to the assigned EU Competent Authority by 31 March of the following year\*.

Operators can report either their actual emissions or the estimated emissions using the Small Emitters Tool or the ETS Support Facility, both from EUROCONTROL.

Before submission to the Competent Authority, the emissions report must be verified by an accredited verifier.

(\* ) 28 February for operators reporting to Spain
