Dear Sir, dear Madam,

In October 2008, the European Parliament and the Council of the European Union adopted the directive 2008/101/EC¹ which includes aviation activities in the scheme for greenhouse gas emission allowance trading within the Community.

In application of this directive, aircraft operators may ask for allowances issued free of charges for some of them for 2012 and for the 2013-2020 period.

Each aircraft operator will be regulated by a single Member State in respect of all their activities to, from and within the EU. You are as an aircraft operator attached to France.

The French GHG registry, held by Caisse des Dépôts et Consignations is responsible for managing this system for France. In this capacity, it has to open an account for you in the Union Registry. Your details have been sent to us for this purpose by the Directorate of Civil Aviation of the French Ministry of Ecology, Sustainable Development, Transports and Housing.

For this purpose, please kindly:

- 1) fill in and sign the application form attached to this mail and return it as soon as possible to our attention via post
- 2) enclose the supporting documents² (original or certified true copies) required in application of the new registries regulation « RegReg V » voted on 17 June 2011 (see appendix IV et IX),

and send all the documents to the following address :
